

KOSHKONONG TOWN BOARD MINUTES
JUNE 14, 2006

Chairman Swart called the June 14, 2006 town board meeting to order at 7:00 PM at the town hall with Supervisors Carol Clavey, John Debereiner, Randy Harris, Jae Ames, Treasurer Judith Almquist, and Clerk Brigetta Nelson were present.

Neighbors voiced their concerns to Jefferson County Sheriff's Department about noise, and other problems on Vinne Ha Ha Road.

Clavey/Harris made a motion to close the public hearing on Liquor License for July 2006 - June 2007. Carried.

Ames/Debereiner made a motion that the completed Liquor Licenses be approved as presented. Sammy's, Hilltop Inn, and VFW we need more information from, before the licenses are renewed, and have the liquor confined to the building. Carried.

Betty Barrows-Highfield: Ames/Clavey made a motion to approve the conditional use permit for a barn with indoor riding arena, conditional that construction does not start until the covenants runs out on July 19, 2006. Also, that property owner has Onyx take care of the manure. Carried.

Ron Plambeck: Ames/Debereiner made a motion to approve the land division at N595 Old 26 Road to create one new lot. Carried.

Debereiner/Clavey made a motion to move to Ramesh Shah. Carried.

Ramesh Shah Annexation: Harris/Clavey made a motion to approve the annexation as presented. Carried.

Ames/Clavey made a motion to waive the previous agreement and accept the \$500.00 in leu. Carried.

Dog and Weed Commissioner Wages: Ames/Debereiner made a motion to appoint Marion Kutz as the weed and dog commissioner for 2006 and pay her \$6.00 an hour plus mileage compensation according to current IRS allowance for weed commissioner. Carried.

Harris/Clavey made a motion to compensate Marion Kutz \$200.00 plus mileage as the dog lister for 2006. Carried.

Clavey/Harris made a motion to put Jefferson County Bridge and Culvert Aid down by Road Work. Carried.

Steve Bock: Harris/Debereiner made a motion to table till next month or until Mr. Bock is present. Carried.

Ames/Harris made a motion that he needs to demonstrate a hardship for the need for a second driveway. Carried.

John and Sally Schwarz: Ames/Debereiner made a motion to approve the construction of a split rail fence based on the fact that it is 20' off the right of way and fence will have a standard height. No permit is needed. Carried.

Fence Ordinance: Swart/Harris made a motion to have Supervisor Ames contact Wisconsin Towns Association or Attorney Tim Fenner on re-wording our ordinance. Carried.

Road Work: Ames/Harris made a motion to have Chairman Swart get bids from contractors and the County on Tri County Road, Poeppel Road, Hackbarth, and Blackhawk Island Road. Carried.

Jefferson County Bridge and Culvert Aid: Swart/Clavey made a motion to table until next month. Carried.

Employee Handbook: Swart/Clavey made a motion to table until next month. Carried.

Edgewater Road: Ames/Harris made a motion to table until will receive a letter from the City of Fort Atkinson saying they will take over snowplowing Edgewater Road. Carried.

Registration Deputy: Swart/Clavey made a motion to approve the Resolution to allow registration deputies. Carried.

Minutes: Clavey/Debereiner made a motion to approve the May 10th minutes as presented. Carried.

Ames/Clavey made a motion to approve the May 17th minutes as presented. Carried.
